

WASTE MANAGEMENT

INSTRUCTION FOR VESSELS

In Pietarsaari port area, instructions for waste management must be followed by taking in and handling waste from vessels and port operations. These instructions are based on laws and regulations on waste management given by the European Union and Finnish State. By following these instructions and delivering waste appropriately to waste collection stations, an environmental load caused by waste from vessels and port operations can be decreased and contaminations of marine environment prevented.

WASTE MANAGEMENT CHARGES OF VESSELS

The currently valid tariffs for solid and oily waste are charged from all vessels in the port of Pietarsaari/ Jakobstad, except vessels exempt from the obligation to leave waste at the port. Oily waste from engine room, black/grey water and solid waste are included in the waste management fee. Hazardous and mixed waste are charged according to actual costs added with general fee.

Violations of the instructions for waste management are liable to compensate any extra costs incurred by the Port of Pietarsaari/Jakobstad.

WASTE RECEPTION EQUIPMENT

There are three (3) separate waste collection stations in the port area. These waste collection stations are marked with signs JÄTEASEMA – AVFALLSSTATION – WASTE STATION. The possessor of waste is obligated to deliver sorted waste to the waste collection stations

It is indicated on the side of the collection point what type of waste it is intended for.

The receipt of any waste requires an advance notice to the Port Control, t. +358 6 723 1388, portcontrol@portofpietarsaari.fi. Delivery must be supervised by the Port Control. It is forbidden to leave waste outside of waste collection station.

The receipt of oily waste or sewage requires an advance notice 24 hours prior to the intended time of delivery to the Port Control, t. +358 6 723 1388, portcontrol@portofpietarsaari.fi.

Waste collection system of the Port of Pietarsaari does not include:

- ballast water of tankers
- washing water of tanks
- waste originating from cargoes IMDG/ADR/ RID-classes

Regarding these types of waste, vessels must order direct service from waste management company.



RECEPTION OF CERTAIN TYPES OF WASTE

RECYCLABLE PAPER AND CARTON

- newspaper and magazines, leaflets, coloured paper, envelopes and recycled paper
- carton packaging (cereal boxes, cookie wrappers, egg boxes), liquid cartons (milk, juice, yoghurt, wine and detergent containers), corrugated cardboard, paper shopping bags and sacks, paper bags, paper roll cores, gift and wrapping paper

RECYCLABLE GLASS

empty glass bottles, empty glass jars

RECYCLABLE METAL

 tin and metal waste, clean cans, metal ware, cables, empty and brush dry paint cans and metal furniture

ENERGY WASTE

 non recyclable plastic, rubber, styrofoam, soiled paper and cardboard, clean; treated wood and paper towels

PLASTIC

 plastic packaging and wrapping, rims and bands, boxes, tubes, bottles and canisters (rinsed, caps off), EPS (expanded polystyrene) packaging

BIOWASTE

 food stuffs, coffee filters with grounds, paper towels and paper napkins, egg packagings, wooden cutlery, tooth picks and other degradable waste

HAZARDOUS FOOD WASTE FROM INTERNATIONAL TRANSPORTATION

 foodstuffs from vessels arriving from outside the EU area

SOLID OIL WASTE


oily cotton waste and oil filters, canisters etc.
max. size 50 cm × 50 cm × 50 cm

OIL BEARING MIXTURES

- oil bearing mixtures including oily bilge water, sludge and waste oil
- no separate tanks in port area, pumping to tank lorry, advance notification required

OTHER HAZARDOUS WASTE

 paints and glue barrels, brushes, batteries, assemblers, fluorescence tubes etc.



WASTE ELECTRICAL AND ELECTRONIC EQUIPMENT

• small machines, washing machines, dishwashers etc.
